Various tasks were carried out both in the City Centre and within the City Hall that would have been performed regardless of the event, albeit possibly at different times. Consequently, there were no extra expenses incurred. All duties were completed within regular working hours, eliminating the need for overtime costs.

- 2. All costs associated with organising the event were accommodated from existing budgets.
- 3. No financial support was received from the Isle of Man Government.
- 4. The closure of the City Hall was a security request from Buckingham Palace. E-mails and correspondence in relation to the matter are exempt from disclosure under Section 23 of the Freedom of Information Act, communication with the Crown. This exemption is an absolute exemption which means the Council does not have to consider whether disclosure of the information would be in the public interest. Although the City Hall was closed for security reasons, please note that all services provided by the Council operated as normal, and all employees continued to work from different locations or remotely. The City Hall was closed from Monday, 18th March to Wednesday, 20th March, 2024.
- 5. As listed in response 1, the cost of the plaque presented to Her Majesty Queen Camilla totalled £194.76 and was sourced from the local company Manx Rockcraft and Celtic Engravings.
