#### 1. One Minute Silence

The Council stood to observe a one-minute silence for former Tramways Superintendent, Mr M.C. Crellin who had sadly passed away.

## 2. **Minutes – 9<sup>th</sup> October, 2024**

#### 3. Standing Order 39 – Question – Mr Councillor P.J. Washington

Mr Councillor P.J. Washington asked the Chair of the Housing and Property Committee:

- 1.1 In the last five years, how many letters have been sent out by Douglas City Council's Housing Department to tenants stating that, following the death of your husband who was the tenancy holder, can you come down and sign a new five-year fixed term tenancy.
- 1.2 In the last five years, how many letters have been sent out by Douglas City Council's Housing Department to tenants stating that, following the death of your wife who was the tenancy holder, can you come down and sign a new five-year fixed term tenancy.
- 1.3 As a result, of sending out the above letters, in the last five years, how many widowers have been placed on a five-year fixed term tenancy.
- 1.4 In the last five years, how many widowers have been placed on a one-year fixed term tenancy.
- 1.5 In the last five years, how many widows have been placed on a five-year fixed term tenancy.
- 1.6 In the last five years, how many widows have been placed on a one-year fixed term tenancy.

Reply by the Chair of the Housing and Property Committee:

The Council is unable to provide an answer to questions 1.1 to 1.6 as this information is not currently collected and collated. However, the process that the Council follows in these difficult scenarios is in accordance with the Department of Infrastructure's 'Guidelines on the Implementation and Management of Fixed Term Tenancies in Public Sector Housing 2023'.

#### 4. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Chair of the Housing and Property Committee:

- 2.1 How many tenants does the Council currently have residing in domestic properties?
- 2.2 *Of the current tenants what percentage pay:*

  - b) by cash weekly
  - c) by other means?

Reply by the Chair of the Housing and Property Committee:

- 2.1 There are currently 2,299 tenants residing in the Council's domestic properties.
- 2.2 *a) Direct debit 43%* 
  - b) Cash 7%
  - c) Other means 50%

## 5. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Leader of the Council:

Following the Department of Infrastructure's recent decision to stop paper collection at the Eastern Amenity Site will the current operators take over this collection service for members of the public who use the facility?

Reply by the Leader of the Council:

The contractor operating the site has suggested to the Eastern District Civic Amenity Site Joint Committee that they continue to provide a paper recycling service for the site, and a price has been provided. This suggestion is currently being considered by the Committee, who it is hoped will make a determination at its next meeting on 19<sup>th</sup> November 2024.
