4. **Standing Order 103 - Privilege**

With the consent of the Mayor Mr Councillor C.C. Thomas rose to plead privilege under Standing Order 103. Mr Councillor Thomas felt personally aggrieved that he could not obtain an unaudited copy of the Council's accounts despite Members of the Executive Committee having copies. Mr Councillor C.C. Thomas also felt personally aggrieved that the Executive Committee considered the Scope of Government Consultation rather than the Council, the Member felt the consultation should have been dealt with in the same manner as the Public Sector Housing Consultation.
