3. Standing Order No. 39 Question – Mr Councillor C.C. Thomas

The following question addressed by Mr Councillor C.C. Thomas to the Leader of the Council and the Leader's reply, were noted:

Question:

Douglas Regeneration

Is there sufficient funding available to Douglas Regeneration Scheme to implement all existing Douglas town centre plans and, if not, which elements are at risk, and how might these elements at risk be taken forward outside the scheme?

Reply:

The Town Centre Regeneration Scheme is funded principally by the Government. There is not, at present, a commitment to fund the whole of the scheme but instead the approach has been taken that it should be phased, and so once detailed approval is given for an element, funding is sought in respect of that element. This process reflects the normal process for funding any capital scheme, whereby approval is required to all the details before funding is committed.

The Council's financial input is into street lighting and signage and set out in the capital programme.

Question:

Council's use of CCTV

How does the Council deal with Subject Access Requests made in respect of CCTV camera footage?

Reply:

In accordance with the Data Protection Act and the Council's Code of Practice for operation of its CCTV system which is on the Council's Website.

5. Standing Order No. 39 Question – Mr Councillor C.C. Thomas

The following question addressed by Mr Councillor C.C. Thomas to the Leader of the Council and the Leader's reply, were noted:

Question

2013-14 Rents

Will he make a statement about the impact on ratepayers and rentpayers of the DSC's i) decision not to approve across-the-board rent increases ii) allegation that inadequate notice had been given of rent increases?

Reply

This matter is still to be fully considered and it would be premature to make any detailed statement at this time. There was a full debate in private at the last Council meeting when a unanimous decision was reached on the proposed course of action which was to increase housing rents. There has been further correspondence with the Department since, and that needs to be considered thoroughly before a statement is made. However the Council's decision, if carried into effect, will have no impact on ratepayers.

The second part of the question relates to the notice given to tenants, which was shorter than would be desirable. However it could not be issued until both the results of the re-pointing exercise and the water rates were known. Once these were known, notice was issued.

6. Standing Order No. 39 – Mr Councillor C.C. Thomas

The following question addressed by Mr Councillor C.C. Thomas to the Lead Member of the Regeneration and Community Advisory Committee and the Lead Member's reply, were noted;

Question

Are there lessons to be learned by the Council from the Noble's Park bowling-green kiosk, toilets and club house episode in respect of i) working with clubs and associations ii) estimating the cost of works and iii) maintenance arrangements?

Reply

The Council continually learns from its experiences and this case is no different. Lessons will be learned, particularly in relation to the scope and scale of works required both in routine maintenance and particular schemes
