Apologies for absence were submitted on behalf of Mr Councillor D.J. Ashford (away on Council business), Mr Councillor D.W. Christian, MBE, JP, Mr Councillor E.A. Joyce and Councillor Ms K. Angela.

The Chief Executive, Assistant Chief Officer (Finance), and Assistant Chief Officer (Housing and Property) were in attendance.

1. **Minutes – 10th June, 2015**

The minutes of the monthly Council meeting held on Wednesday, 10th June, 2015 were approved and signed.

2. Standing Order 39 – Question Mr Councillor S.R. Pitts

The following question addressed by Mr Councillor S.R. Pitts to the Vice-Chair of the Housing Committee, and the Vice-Chair's reply, were noted on the minutes:-

Question:

- a) What was the cost in May of sending 924 rent arrears letters to tenants;
- b) Which estates had letters sent to them;
- c) What has been the response from the tenants;
- d) Who authorised so many letters to be sent;
- e) What was the total outstanding rent of 924 tenants;
- f) How many of the 924 tenants are still in arrears;
- g) What is the total rent now outstanding from the 924 tenants?

Reply:

- a) The number of normal routine rent arrears letters sent out in May 2105 was 324, which incurred £136.00 in postage costs. In addition, 300 one-off letters were sent to tenants in May 2105 requesting that they comply with the terms of their tenancy by providing a week's rent in advance, which incurred a further £126.00 in postage. The remaining 300 letters were further information notices only.
- b) Letters were sent to all estates, as rent arrears letters are sent to all tenants in arrears irrespective of their address.
- c) Generally tenants accepted the fact that they have historically been paying their rent in arrears and have brought their accounts back into credit in accordance with their tenancy agreements. Of the 300 one-off letters sent, the Housing Department received numerous queries but only six verbal complaints were received together with one complaint in writing. 148 tenants have not responded to date.
- d) All letters sent to tenants are checked and approved by Senior Management in the Housing Department prior to issue.
- e) The actual amount of arrears for the 300 one-off letters sent in May 2015 would require further significant resources to investigate and calculate. However, based on averages, a conservative estimate would be approximately £24,258.
- f) 148 of the 300 tenants who received the one-off letter in relation to advance rent have not responded to arrange a payment plan. Across the entire housing stock, 424 tenants were in arrears in May 2015 compared to 298 at present.
- g) The actual amount of rent outstanding for the 300 one-off letters sent in May 2015 would require significant resources to investigate and calculate. However the total amount of rent arrears across the whole housing stock (including the 324 routine letters sent in May 2015), was £56,210 and is presently £45,257.

Supplementary Question:

Why does the Members' Bulletin state 924 letters?

Reply:

The total of 924 letters sent out was not sufficiently broken down in the Members' Bulletin. Members now have that detailed breakdown.
