The Town Clerk and Chief Executive, Director of Finance, Director of Environment and Regeneration, and the Director of Housing and Property were in attendance.

1. **Minutes – 12th July, 2017**

The minutes of the monthly Council Meeting held on Wednesday, 12th July, 2017, were approved and signed.

2. **Standing Order 39 – Question – Mr Councillor J.E. Skinner**

1) Mr Councillor J.E. Skinner asked the Chair of the Regeneration and Community Committee:

What Section of the Road Traffic Act requires the Main Car Park in Nobles Park to be designated as a public highway?

Reply by the Chair of the Regeneration and Community Committee;

Following the judgement of High Bailiff Moyle in Attorney-General –v- David Roderick Lynn in 2010, (“the Lynn Judgement”), his Worship concluded that the Roadways, although in the private ownership of Douglas Borough Council, were roads within the meaning of Section 72 of the Road Traffic Act 1985.

The management of traffic through the park is currently being assessed in preparation for the production of a Noble’s Park Traffic Management Plan. This assessment is looking at the current highway designation and how it can best be managed in the future. The plan will provide a number of recommendations for consideration through a report to Regeneration and Community Committee regarding how the Council manage and control traffic in the park in the future. It is intended the report will go to Committee in October 2017.

2) Mr Councillor J.E. Skinner asked the Leader of the Council:

With reference to the Equality Act 2017 what steps are being taken to carry out an audit of Council owned public buildings and outdoor space to ensure compliance and accessibility?

Reply by the Leader of the Council:

The Equality Act 2017, which received Royal Assent on 18th July 2017, deals with discrimination comprehensively in respect of both employment and the provision of goods and services on various grounds including race; religion; sexual orientation; age; disability; and gender reassignment.

The implementation dates for many of the main equality provisions in the Act will be made later in 2017, with all of the provisions being in place by January 2020. In respect of provision for those with disabilities under the Act, employers and service providers have to make ‘reasonable adjustments to buildings where practicable’.

The provisions of the Disability Discrimination Act 2006, which is also being introduced in phases, are also relevant in this respect and an audit of Council-owned public buildings is being commissioned through a qualified and experienced external auditor. Further research is being undertaken in respect of the requirements for outdoor space in respect of both Acts.


