1. **Minutes – 14th March, 2018**

3. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Chair of the Regeneration and Community Committee:

- (a) To date how many burials have there been in both The Borough and Lawn Cemetery in each of the last five years?
- (b) How many graves have been opened for second or third burials in each of the last five years?
- (c) Will consideration be given to the Crematorium operating on additional days particularly in view of the high number of deaths this winter and the disruption to services caused by the TT Races, Festival of Motorcycling, Manx Grand Prix and losing a day at Easter which has caused families to have to wait up to three weeks for a Crematorium Service?
- (d) What have been the fees for 'opening and closing earth grave (first interment)' and 'opening and closing earth grave (subsequent interments)' in each of the last five years?
- (e) What is the reason for the sudden and dramatic rise in fees for 'subsequent interment, same grave adult' from £284.80 to £440.00 a rise of £155.20 and to date how many have there been in each of the last five years?
- (f) How many cremations have there been to date in each of the last five years?

(c) Yes, consideration is always given to offering extra days if required throughout the year not just during TT/FoM. Additional days are already planned for both events if required this year.

In the instances of families having to wait three weeks for a service, alternatives are always offered to Funeral Directors to try to accommodate their needs, but on some occasions these alternatives are not taken up because a specific time and day have been requested at times when there is no availability.

4. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Leader of the Council:

- (a) How many Wardens are employed within the Borough?
- (b) In view of the retirement of the Borough Warden Manager and the retirement of the 'Senior' Borough Warden why as at the 3rd April, 2018 is there no-one available in the Wardens Department to retrieve CCTV footage and evidence following complaints and why are all Wardens currently not trained in this area?

Reply by the Leader of the Council:

- (a) There are three Borough Wardens and a Senior Borough Warden. The Senior Borough Warden post is currently vacant with interviews scheduled for Wednesday, 11th April.
- (b) The Borough Warden Manager previously undertook CCTV evidence retrieval for cases in which there was no police involvement. In cases where crimes are involved the Police have been trained to retrieve the footage themselves. The Borough Warden Manager retired at the end of March 2018. Since then CCTV evidence retrieval has been carried out by the ICT team. The Borough Warden Manager's successor, the Community and Enforcement Manager, commenced in his post on Tuesday, 3rd April, 2018 and participated in in-house training session with the Council's specialist trainer on 1st May, along with one of the Borough Wardens. The other two Borough Wardens will participate in this training along with the Senior Borough Warden when they are appointed. At this point the whole team will have been trained.

Supplementary Question

(a) Is the Assistant Chief Officer (Regeneration) trained in the retrieval of images from the CCTV cameras around the Borough?

Reply

(a) The Assistant Chief Officer (Regeneration) is not trained to retrieve CCTV footage. The need for this training has not been identified when there are other staff who are able to undertake this function, including staff from ICT and Isle of Man Constabulary as and when required.
