1. **Minutes – 12th December, 2018**

2. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Leader of the Council:

"What plans are there to update policies and advice given to officers, staff and members on both bullying and "whistleblowing"?

Reply by the Leader of the Council:

"The Council does have a Policy on Bullying, Harassment and Victimisation, which is to be reviewed in line with the Government policy on Fairness at Work (which replaced its Bullying, Harassment & Victimisation policy).

There is also a policy in place on Whistleblowing, which was approved by the Council on 8th November 2017 and is to be reviewed biennially. Again, it is largely based on the Government's Code.

These documents are readily available to staff and advice is available if required from the Human Resources Section. There will be consultation when they are reviewed and all staff will be informed of the outcome.

In relation to Members of the Council, the prime guidance is in the Constitution where both the Members' Code of Conduct and the Protocol on Member and Officer Relationships offer advice. As elements of the Constitution these are both regularly reviewed and will be again when appropriate or if any Member brings forward a suggestion."
