The Director of Housing and Property (as Acting Chief Executive), the Director of Finance and the Director of Environment and Regeneration were in attendance.

1. **Minutes – 4th August, 2021**

The minutes of the Special Council meeting held on Wednesday, 4th August, 2021, were approved and signed.

2. **Minutes – 11th August, 2021**

The minutes of the Annual Council meeting held on Wednesday, 11th August, 2021, were approved and signed.

3. Standing Order 39 – Written Question – Mr Councillor F. Scheungel

Mr Councillor F. Scheuengel asked the Chair of the Housing and Property Committee:

When can residents of Spring Valley expect a timeline with regards to renovation and developments on their estate?

Response by the Chair of the Housing and Property Committee:

Residents will be given a construction timeline when we get petition concurrence / approval from DOI and Treasury. Only at this time will the project be at a point where we can be confident it will continue.

There are a number of stages to go through before we can get to this point. These are;

- BC Business case stage;
- DI-Design;
- *I1 Design Development;*
- I2 Technical Design;
- *I3 Tender Stage.*

We are currently at the first stage, BC - business case development.

The different stages can take from a few weeks to several months, the completion of each stage is dependent on a multitude of factors, including final sign-off from the Department of Infrastructure. It is therefore very difficult to give an accurate timeline of events.

Stakeholder engagement will be an incredibly important process during the life cycle of this project, this will include continued consultation with existing tenants and possible future tenants.

A regular communication stream with our tenants will keep them fully informed of progress and any possible set-ups, therefore clearly managing expectations.

In the next 2 weeks we will be issuing a formal communication to the tenants in the form of 'a friendly and accessible' leaflet. This will be followed up by some initial tenant surveys, enabling us to build up a picture of our customer requirements for the new estate. We will endeavour to engage as many stakeholders as possible during the process.
