1. One Minute Silence

The Council stood to observe a one minute silence for former Head of Parks, Mr Dave Hewes, who had sadly passed away since the last meeting.

2. Election of Leader of the Council and Chair of the Executive Committee

The Mayor invited nominations for a Member to serve as Leader of the Council and Chair of the Executive Committee for the municipal term 2023 to 2025.
