Apologies for absence were submitted on behalf of Mr Councillor C.L.H. Cain and Mr Councillor J.E. Skinner.

The Chief Executive, Borough Treasurer and Borough Engineer and Surveyor were in attendance.

1. **Minutes – 13th May, 2015**

The minutes of the annual Council meeting held on Wednesday, 13th May, 2015 were approved and signed.

2. Standing Order 39 – Question Mr Councillor S.R. Pitts

The following question addressed by Mr Councillor S.R. Pitts to the Chairman of the Housing Committee, and the Chairman's reply, were noted on the minutes:-

Question:

- (a) Between what dates has 70 Hillside Avenue been unoccupied;
- (b) What is the loss of rent and rates to date;
- (c) What works have been carried out;
- (d) Please provide a detailed breakdown of the costs;
- (e) When will the property be ready to let;
- (f) What is the reason for the property being empty so long;
- (g) How many properties have been or are unoccupied for more than 3 months since 70 Hillside Avenue became vacant.

Reply:

- (a) This property was unoccupied from 21st October, 2013 until 1st June, 2015.
- (b) Rent loss for the unoccupied period was £6,712.69 (deficiency funded). The amount lost in Borough rates was £1.169.36.
- (c) The works carried out included asbestos checks and associated works; full central heating system installation; complete electrical upgrade; removal of gas fire and associated fittings; repairs to kitchen and bathroom; repairs to doors and windows and general re-let standard works including a thorough clean and continuous garden maintenance.
- (d) The costs were:

- (e) The property was re-let in May this year and the tenant took occupancy on 1st June 2015.
- (f) The voids maintenance team has over the last three years been working on a large number of void properties caused by the recent capital schemes. Properties have been prioritised for those in most demand. (2 bed properties) (See also Briefing Note issued to Executive Committee Members and copied to Housing Committee Members).
- (g) 115 properties have been unoccupied for more than three months during the period of 21/10/13 to 01/06/15.

Supplementary Question:

Is the Chairman happy with the amount of time taken to turn properties, especially to Hillside Avenue, around?

Reply:

I am certainly not happy with the time taken to turn properties around. I have asked the Housing Department to put together a Capital Scheme to reduce voids.

14. Miscellaneous Business

The Chief Executive reported to the Council that a vacancy has arisen in Murray's Ward as a result of Mr Councillor W.M. Malarkey taking up a seat in the House of Keys. Public notice of the vacancy had been issued and nominations closed on 8th June, 2015. No valid nominations have been received and public notice of the vacancy will be re-issued in due course.

The meeting adjourned at 5.20pm whilst the Executive Committee met to consider the appointment of a Member to the Environmental Services Committee to fill the vacancy caused by the election of Mr Councillor W.M.
