2. Executive Committee – 14th January, 2021

Borough Rate 2021/2022

Motion moved by Mr Councillor D.W. Christian, seconded by Councillor Mrs C.L. Wells, "That the minutes of proceedings of the Executive Committee, as contained in report of special meeting held on Thursday, 14th January, 2021 and containing the recommendation;

"That in accordance with Section 11 of the Local Government Act 2006, a Borough Rate of **FOUR HUNDRED AND FIFTY-ONE PENCE** in the pound, a 1.6 percent increase on the net annual value of all rateable property in the Borough be levied for the year ending 31st March 2022."

together with the associated Budget Report and Estimates be received, approved and adopted by the Council."

Further Motion moved by Councillor Mrs C.L. Wells, seconded by Mr Councillor I.J.G. Clague "That the Council consider the Motion in Committee."

Question put on further Motion; a vote was taken by division list and the Motion was carried unanimously.

On resumption of proceedings in Council:

Amendment moved by Councillor Mrs C.E. Crawley, seconded by Councillor Ms J. Thommeny, "That the budget be amended to include the provision for a toilet at Douglas Golf Course being moved forward to the 2021-22 year, and funded from General Revenue Reserves."
