APPLICATION FOR A HIGHWAY LICENCE FOR AN ADVERTISING BOARD THE HIGHWAYS ACT 1986, SECTION 78

Douglas Borough Council will consider applications by businesses wishing to place advertising 'A' boards in pedestrian areas on the public highway in the capital. If you propose to display an 'A' board as part of a pavement café, please include it in your pavement café application. Applications will only be approved if they comply with the following policy which has been approved by both the Council and the Department of Infrastructure;

- 1. Only one 'A' board will be allowed per premises. Where there are multiple occupants in one building or in close proximity on a street, where appropriate, they are required to combine their 'A' boards to ensure that there are not excessive numbers of 'A' boards in any one location.
- 2. 'A' boards include all advertising boards, stands, displays, including 'A' frame boards within the following size range; 1,000mm and 1,200mm high, 300mm to 1,200mm wide by a maximum of 600mm deep.
- 3. No board is to be placed such that it protrudes beyond a point 1000mm from the frontage of the premise; any advertising board should always be positioned so that it touches the wall of the related property. No advertising board should be placed at the edge of the footway.
- 4. No board will be hand-written (except blackboards), or painted or printed in a style appearing to be hand-written. Blackboards must have a non-handwritten header or surround showing the establishment to which it belongs.
- 5. All licensed boards are to be maintained in a clean and tidy fashion.
- 6. The applicant will indemnify Douglas Borough Council against any claims for loss, injury or damage resulting from the placement of the 'A' board on the highway. The operator will also be obliged to demonstrate that the 'A' board is suitably insured for third party liability.
- 7. All 'A' boards are to be removed from the highway outside of the hours of operation of the business.
- 8. Douglas Borough Council, the Department of Infrastructure and statutory undertakers retain a right to undertake work on, over and under the highway and the grant of a highway licence does not affect this right. No claims for loss of revenue resulting from such works will be considered.
- 9. A minimum unobstructed width of 2 metres must be maintained between the upstand of the kerb (or any existing street furniture) and the 'A' board to allow the free passage of pedestrians. In pedestrianised areas where emergency access is required, an absolute minimum clear width of 4 metres will be required.
- 10. Douglas Borough Council reserves the right to refuse applications or apply additional conditions due to the specific circumstances of the site and setting of the applicant's premises.
- 11. The Department of Infrastructure reserves the right to check each licence (by Planning and Highways Authorities within the Department) prior to it being issued and to refuse any license.
- 12. In the event that the application is refused, the applicant has the right to ask Douglas Borough Council to appeal in writing to the Department of Infrastructure, Local Government Unit within twenty-eight days of the refusal. Appeals will be referred to the Minister for Infrastructure to determine. Once a decision has been made on the appeal, then there is no further right of appeal, however the applicant may re-apply after twenty-four months have elapsed or if there is a material change in circumstances.
- 13. The Department of Infrastructure reserves the right to remove an obstruction on the highway.

All applications will be dealt with in accordance with the procedures set out in section 78 of the Highways Act 1986. This involves Douglas Borough Council undertaking formal consultation with statutory undertakers and the Department of Infrastructure. The Council must also advertise your application in the local press and allow 28 days for any public objections to be received prior to making a decision. You will also be obliged to display a site notice advertising the application in the relevant premises during this period.
