1. **Minutes – 14th December, 2022**

The minutes of the monthly Council meeting held on Wednesday, 14th December, 2022, were approved and signed.

2. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Chair of the Regeneration and Community Committee:

What costs for Heras fencing have been incurred by way of (a) rent (hire) and (b) purchase since the changing rooms at Spring Valley football pitches were first confirmed as unfit for purpose?

Reply by the Chair of the Regeneration Committee:

Pulrose Changing Rooms were condemned on the 18^{th} March 2022 and the site had to be made safe immediately. As a consequence the site had to be cordoned off immediately to comply with Health & Safety Regulations. Heras fencing was hired from a local supplier and installed on the same day to prevent the general public access to the unsafe building. The fencing was hired until the 27^{th} May 2022 for the total cost of £1,584.00 plus VAT.

By the end of April it was then known what the long term plan was to be for the building. A review was undertaken of the costs for the hiring against purchasing the Heras fencing. Quotations were obtained for the purchase of the fencing from suppliers, and the Heras fencing was ordered on the 16th May 2022 to replace the hired fencing. The lead in time for the fencing to be delivered was 10 working days.

The newly purchased Heras fencing replaced the hired fencing on 27th May 2022. The cost to purchase the fencing was £931.14 plus VAT.

In total the Heras fencing has cost £2,515.14 and the purchased fencing can be used in other Council sites as required.

3. Standing Order 39 – Question – Mr Councillor J.E. Skinner

Mr Councillor J.E. Skinner asked the Chair of the Regeneration and Community Committee:

- 3.1 How many staff vacancies are there currently in the Parks and Gardens Section of the Council?
- 3.2 What steps are currently being taken to recruit and retain staff within the Parks and Gardens Section of the Council and additionally identify what the difficulties are associated with retaining staff?

Reply by the Chair of the Regeneration and Community Committee:

- 3.1 At the time of composing this response, there are six vacancies within Parks Services. There has been a constant rolling vacancy rate of five to six posts throughout the year.
- 3.2 Every vacancy is advertised as soon as possible. The overriding reason for loss of staff and difficulty in recruiting is pay.

Mr Councillor J.E. Skinner asked the Chair of the Regeneration and Community Committee:

Will the Chairman investigate the benefits of Gardens Volunteer Schemes which are common throughout the UK and consider the introduction of such a scheme in the Council's parks, squares and gardens?

Reply by the Chair of the Regeneration and Community Committee:

Yes, Committee can receive a report on the merits and issues with such schemes which will include 'friends' groups and other community ownership initiatives.
